*Lifeguards- \$9.00 per hour per guard- CASH. 2 Lifeguards for up to 40 people or as specified by management.

1. A \$20.00 non refundable deposit is due when scheduling party, balance is due 10 days prior to party. If balance due is not received your reservation will not be confirmed.
2. Pool will open at 5:00pm for parties after the facility has been cleaned by staff. Please do not arrive during regular operating hours to set up.
3. Parties are responsible for clean-up of pool area. Removal of trash to dumpster, clean trash from deck & bathrooms.
4. Private parties will abide by all rules posted at the pool. The pool can and will be closed for disruptive behavior with no refunds.
5. The inclement weather policy is in effect for private parties. Please check the weather prior to beginning your party. If the pool closes for inclement weather after the party has begun, there will be **NO FACILITY REFUNDS** and you will be responsible for paying guards for time allotted. Parties may be rescheduled for another date if weather prevents party. This must be done before starting party.

2010 GIBSON PARK POOL

The purpose of Gibson Park Pool is to offer the community a safe place for swimming during the summer. Lifeguards have been trained and certified by the Red Cross. Water Safety Instructors (WSI's) teach our swimming lessons. The staff at Gibson Park Pool takes pride in this establishment. Safety is our main concern and being able to provide a family like environment for our patrons. Rules have been established for the safety of all patrons and staff. Enforcement of the rules is the responsibility of the staff and the public.

RULES:

All rules apply to adults and children alike.

1. Lifeguards are on duty when the pool is open to the public.
2. Lifeguards will be obeyed and respected by the patrons. Inability to follow this rule will result in ejection from the premises.
3. **NO DIVING IN SHALLOW WATER.** Diving is allowed in designated area in the deep end of the pool after passing the deep - water test.
4. No running inside the pool area.
5. Deep - water & slide tests will be taken by anyone 14 years of age or under at a time designated by the pool staff.
6. No food is allowed near the water.
7. No smoking inside the pool area. Adults are allowed to smoke outside the gate. Children under the age of 18 are not allowed to smoke on county property. Violation of this rule will result in loss of privileges for a specific time and parental notification.
8. No swearing, no public displays of affection and no loud yelling inside the pool area.
9. **CHILDREN UNDER THE AGE OF 8 MUST BE ACCOMPANIED BY AN ADULT.** A maximum of five children per adult will be allowed. (Larger groups must make prior arrangement with the pool manager.)
10. Lifeguards are responsible for guarding the pool, not babysitting. You are responsible for the behavior of your children while at the pool. Inability to follow this rule will result in ejection from the premises.
11. Children under the age of 18 must remain inside the pool area until leaving.

LIFEGUARDS HAVE FINAL SAY IN ALL MATTERS OF SAFETY, REGARDLESS OF RULES

WEATHER POLICY:

Thunder and lightning indicates a threat to life. Within 15 minutes of the first thunder, the pool will be closed and all patrons are to leave the premises. The pool will reopen 30 minutes after the last thunder. Parents are responsible for transportation of children. Violations of this rule will result in loss of pool privileges for a specific period of time. Please check the local weather before paying admission. In case of bad weather people who have paid admission will be allowed back in the pool upon reopening the SAME day.
