## **Vehicle Registration**

#### Purchased a vehicle from and individual out of state or in NC

- A. A valid state issued driver's license or ID card
- B. Title that has been correctly signed over
- **C.** Odometer statement if the vehicle is less than 10 years old and must be signed by the seller and buyer
- **D.** North Carolina insurance information
- E. Damage disclosure statement must be signed by the buyer
- F. Title application (MVR-1) completed (including any and all liens) and notarized
- **G.** Title fee of \$56.00, Highway use tax (3% of value set by DOR), Plate fee (depending on type of vehicle), and property taxes are due at the time of transaction.
- **H.** Vehicle will require a safety inspection one year from issuance of NC plate if purchased from another state, if purchased from a North Carolina owner, the vehicle will need a current inspection prior to registration.

### Vehicle purchased from a dealer

- A. A valid state issued driver's license or ID card
- B. Title or MCO (manufacture's certificate of origin) properly assigned
- C. All accompanied trace documentation (reassignments from one dealer to another, ect.)
- D. North Carolina insurance information
- E. Bill of sale
- F. Damage disclosure statement signed by the buyer
- **G.** Odometer statement signed by the seller and buyer
- H. Title application (MVR-1) completed (including any and all liens) and notarized
- I. Title fee of \$56.00, Highway use tax (3% of purchase price plus DOC fee minus trade in difference), Plate fee (depending on type of vehicle)
- J. <u>Dealerships DO NOT pay property taxes on the purchase of the vehicle, that is the buyers responsibility!</u>

# Vehicle coming in from another state and is already in the owner's name

- A. A valid state issued driver's license or ID card
- B. Title with registered owner's name listed as the owner
- C. Odometer statement if less than 10 years old and must be signed
- D. Damage disclosure statement must be signed by owner
- E. North Carolina insurance information
- F. Title application (MVR-1) completed (including any and all liens) and notarized
- **G.** Title fee of \$56.00, Highway use tax will be capped off at \$250.00 if titled exactly as it was in previous state but may be less depending on the age of the vehicle, Plate fee

(depending on type of vehicle), and Property taxes (based on what the DOR sets the value of the vehicle at as well as where you live)

## Out of state title held by recorded lien holder

- A. A valid state issued driver's license or ID card
- **B.** Out of state registration in owner's name (CAN NOT be more than 6 months expired!)
- C. Odometer statement if less than 10 years old and must be signed by owner
- D. Damage disclosure statement must be signed by owner
- E. Lien holder's name and correct mailing address for title work
- F. North Carolina insurance information
- G. Title application (MVR-1) completed (including lien holder information) and notarized
- **H.** Title fee of \$56.00, Highway use tax will be capped off at \$250.00, Plate fee (depending on type of vehicle), and property taxes are due at time of transaction
- I. Vehicle will require a safety inspection one year from the time of issuance
